










ENERGY CONTRACTS

An energy contract cannot be considered as just another typical commercial agreement. It is of the utmost importance to pay adequate attention to the specificities and complexity of this type of commercial agreement.

We assist in the setting-up and revision of specific fully-fledged energy contracts. This is a key area of our Energy practice. We take into special consideration the latest regulatory developments and legal doctrine while setting up or reviewing your energy contract.

We offer our expertise in both regulated and commercial energy contracts. On the regulated contracts side, this expertise includes (negotiation on) connection and access contracts, transit contracts or access responsibility contracts. Specific commercial energy contracts vary from gas and electricity supply general conditions and term sheets, to O&M/BOT contracts for energy projects and to high-standard energy contracts such as tolling agreements, wheeling agreements or DDCA agreements.

Finally, the traditional rights in rem, such as property titles, zoning, mortgages, site ownership (agreements), option agreements, building and planting rights agreements, site concession agreements, rental agreements, lease rights, servitude and passage rights are often also to be examined in the light of the specific energy project and in this regard we have the necessary capability.

ENERGY DISPUTE RESOLUTION

It is clear that, in the constantly changing and complicated market of electricity and gas, unavoidable disputes arise between market players and governments. Dispute resolution in the Belgian energy sector requires strengths in multiple branches of the law, ranging from commercial (contracts) law to administrative and public law.

The Energy practice at Lydian comprises various members who are experts in dispute resolution, having expertise in commercial litigation, proceedings before administrative and constitutional courts and arbitration in this area. In a prior stage, we advise on dispute prevention, foreseeing clarity and transparency on dispute resolution in contracts, or through negotiation in dispute issues.

ENERGY AND PROJECT FINANCE

Energy law and project finance are inextricably linked, going hand in hand in any energy project. Lydian has assisted in the elaboration of various large and medium scale energy projects for electricity generation in Belgium, involving both fossil fuels and renewables. We have been able to work on the project finance side on many large-scale energy transactions, in which we advised private companies as well as (PPP) government bodies.

Legal assistance in energy projects covers typical project finance issues, such as setting up financing structures, finance documentation, tailoring the appropriate security interests, including derivatives schemes. On the energy side of the project, this category of work involves both the preliminary contacts with the regulatory authorities and permit-issuing administrations, as well as the development of tailored corporate and contractual mechanisms within the regulated framework of network access.

EMISSION TRADING SCHEMES AND CLIMATE CHANGE

Combating climate change requires a joint effort from governments, companies and the public. Progress has been made through international and regional agreements, public awareness initiatives and policy changes.

The different laws that are now in place in order to mitigate climate change influence and often limit or support the actions of energy market players. Climate change has become a fully stand alone part of energy law, in which our lawyers at the Energy practice have gained expertise in: regulatory monitoring of and the provision of advice to industrial players on (GHG) emission trading schemes; providing assistance with regard to the NAP (Belgian National Allocation Plan) related issues; CDM/JI projects; capital markets; etc.

RENEWABLE ENERGY

Over the past 15 years, the Belgian energy sector has changed dramatically. The structure of the Belgian energy market has been transformed from a closed, monopolist and national market with a public character, to an open trade European and international market, with multi-level players, in which renewable energy projects and support thereof is becoming increasingly important. The "renewable" stamp can be found everywhere: from solar, wind or biomass projects, green subsidies and certificates, to energy efficiency and conservation in buildings and machines.

In our Energy practice, we have experts advising on renewable energy law since the market changes in the 90's and 2000's. We assist major players in their construction projects for new power plants, both fossil fuelled as on the basis of renewable sources of energy.



ENERGY REGULATION

The Belgian and European energy markets are strictly regulated.

In Belgium, regulatory powers regarding the energy markets are divided between the Federal State and the Regions. The federal authorities regulate electricity and natural gas tariffs, the high voltage electricity grid (with a voltage of over 70 kV), the storage and transport of natural gas, the production of electricity (with the exception of the production of electricity from renewable energy sources and combined heat and power systems) and nuclear power. The Regions concern themselves with the distribution of electricity via networks with a voltage of less than or equal to 70 kV, the distribution of natural gas, the production of electricity from renewable energy sources and combined heat and power systems, rational use of energy and social public service obligations.

This means that in this relatively small country, no less than four market regulators (one federal, three regional) issue new rules on market access, consumer rights, tariffs, technical requirements, etc. on an almost daily basis. They also issue a significant number of guidelines and interpretations, adding to the complexity of the regulatory framework. Finally, transport and distribution of electricity and gas are controlled by government-held agencies and companies (often with an important role for municipalities).

It is therefore important both for market parties (especially new entrants) and governmental agencies and companies to be able to secure accurate and up-to-date legal advice on the ever changing legal framework as well as solid legal assistance whenever this legislation is brought before the courts (e.g. the Constitutional Court in case of legal review or the civil courts in case of disputes over tariffs or green certificates).

ENERGY PROJECTS

We provide a full range of legal services to energy companies related to the ownership, development, and finance of their real estate, transmission, generation, and related facilities.

Clients include energy companies, utilities, contracting and construction companies, financial institutions and equity providers.

Our project experience ranges from complex procurement and construction agreements, the subcontractor agreements, the interface between the different layers of contractors, the direct agreements with the lenders, the engineering and documentation of the underlying equity, junior and senior debt structures (including EIB related solutions), insurance advice, to cost-effective management of legal requirements for smaller supporting facilities such as rights of way, rights to build, rights of uses and leases.

We assist our energy clients in relation to power generation facilities, solar facilities, high voltage power lines and wind farm developments, as well as providing day-to-day legal support.

Further, we assist our clients in many permit application procedures for energy projects, such as operating and environmental permits.


